#### 4. First-aid Measures

**FIRST AID - EYE CONTACT:** Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed.

FIRST AID - SKIN CONTACT: Wash skin with soap and water. Remove contaminated clothing. Get medical attention if irritation develops or persists.

#### 5. Fire-fighting Measures

# 7. Handling and Storage

Store large quantities in buildings designed and protected for storage of NFPA Class I flammable liquids. #### PERSONAL PROTECTION

# 10. Stability and Reactivity
